In 1995, Mrs Koh was appointed a District Judge in the Subordinate Courts and subsequently became the Principal District Judge, Family and Juvenile Justice Division until December 2003, when she was appointed Registrar of the Supreme Court. On 11 April 2008, Mrs Koh was appointed Solicitor-General.

Mr. Overmyer enjoyed nearly 30 years of experience in the telecommunications industry, including 12 years as a senior executive based in Singapore. As Vice President of Global Services for AT&T in Asia, Mr. Overmyer managed a successful, \$300 million business unit across 35+ Asian, South Asian and Pacific Island markets. He has in-depth knowledge of the Asian governments' evolving industrial and regulatory policies on telecommunications, digital technology and internet related services. Mr. Overmyer served as Chairman of the American Chamber of Commerce in Singapore and of the Singapore International Chamber of Commerce. He also served as a senior member of advisory boards to Asian governments on information technology, labor relations, economic development and education. Mr. Overmyer has a Bachelor's Degree in Electrical Engineering from the University of Illinois and Master's Degrees in Management from both Pace University and Stanford University. He completed the Sloan Management Program at the Stanford University Graduate School of Business and The Executive Program at the University Of Virginia Darden Graduate School Of Business Administration.

Mr. Stuart Isaacs QC - London; Singapore

Stuart Isaacs QC practises from his prominent London Chambers in the fields of commercial law, international arbitration and EU law. He is also the Studin sades QC practises from his profilment London Chambers in the fields of Confinencial law, international arbitration and ED law. He is also the first and only London-based QC to have been authorised by the Attorney General of Singapore to practise as a foreign lawyer in Singapore, where he maintains his own office to serve better his clients in the region. He appears frequently in the Commercial Court and Chancery Division, the European Court and in the appellate courts, including the House of Lords and Privy Council, as well as in the courts of other common law jurisdictions. Since becoming a Queen's Counsel in 1991, he has been appointed to numerous arbitration tribunals and, more recently sits as an accredited mediator. In over 30 years of practice, Stuart has appeared as counsel in hundreds of court cases and arbitrations in London and around the world. He has a large

commercial practice in Asia and visits the region frequently to advise and appear in arbitrations and to act as an arbitrator. Recognised as a leader at the Bar in all of his areas of practice, Stuart is regularly singled out in legal directories for his outstanding legal and technical abilities. Noted as having a practice of international standing, he is also commended for his 'tactical head' and as being a 'strong litigator' and 'superb tactician' who 'gets results that others only dream of'.

Session 5: "Legal Professional Privilege for In-house Counsel"



Session Chair: Mr. Lok Vi Ming SC Partner Rodyk & Davidson LLP, Singapore

Lok Vi Ming S.C. is head of the Rodyk & Davidson's Aviation Practice Group. He was appointed Senior Counsel in January 2005. He handles many of the firm's major litigation cases and is the solicitor in charge of the teams which conducted the successful defence of the MI 185 crash and all Singapore claims related to the SQ 006 accident. A prominent aviation lawyer in Singapore, Vi Ming has been involved in every major litigation in Singapore relating to Aviation Law in recent years. He has lectured at the Aviation Law course at the Faculty of Law and at the Singapore Aviation Academy.

He is immediate past Chairman of the Aerospace Committee of the Inter-Pacific Bar Association and is on the International Advisory Panel of the Registry of Aircraft Parts established under the Cape Town Convention. Vi Ming also featured in Euromoney Legal Media's Guide and Guide to the World's Leading Insurance and Reinsurance lawyers and also in all the recent editions of the International Who's Who of Aviation lawyers. Vi Ming is a Fellow of the Singapore Institute of Arbitrators and has been appointed to the Regional Panel of Arbitrators with the Singapore International Arbitration Centre. He is a Fellow of the Singapore Academy of Law and is on the committee for the International Promotion of Singapore Law. Vi Ming has been appointed by the Hon Chief Justice to chair Disciplinary Committees convened to hear complaints into the conduct of lawyers. He has also engaged and managed third-party service providers to supplement and augment the testing aspects of these programs.
